

TERMS & CONDITIONS

1. It is candidates' responsibility to ascertain and ensure their eligibility as per the prescribed qualification and experience. 2. **Tenure:** The assignments are purely on contract basis for a period of **36 months**. These Appointments will not vest any right to claim by the candidate for regular appointment or permanent absorption in AIIMS, Patna/ICMR or continued contractual appointment.
3. **Expiry of Contract:** The contract will automatically expire on completion of 36 months or earlier in case of withdrawal of support by funding agency. The contractual appointment can be terminated at any time by either side by giving 30 days' notice or salary in lieu thereof.
