Annexure II

Terms and conditions governing the appointment of Specialist Doctors on Part Time Contract Basis and Medical Officer on Full Time Contract Basis at IIT Patna Hospital.

1. The appointment is purely on part time/full time contract basis for a period of one year , with effect from the date of joining. The contract can be further extended for next two years (on yearly basis) based on performance. The appointment can be terminated at any time (on either side) by giving one month's notice without assigning any reason.
2. The consolidated remuneration of Part Time specialist doctors will be Rs.5000 per visit of 4 hours during first year. The consolidated remuneration of Medical Officer will be Rs.75000 per month (consolidated) during first year. The appointee shall perform the duties assigned to him/her. The competent authority reserves the right to assign any duty as and when required. No extra / additional allowance will be admissible in case of such assignment.
3. The appointee shall not be entitled to any benefit like Provident Fund, Pension, Gratuity, Medical Attendance Treatment, Seniority, Promotion etc. or any other benefits/allowances available to the Government Servants, appointed on regular basis.
4. Non practicing allowance will not be admissible.
5. The appointee will not be granted any claim or right for regular appointment to any post under IIT Patna.
6. The appointment to the said post will be subject to the certificate of physical fitness from the competent medical authority of the Institute. In case the candidate is found medically unfit, he / she will be discharged from the said appointment forthwith
7. The appointee is not entitled to any Travelling Allowance etc. for joining the appointment.
8. If any declaration given or information furnished by the candidate proves false or if he/she is found to have willfully suppressed any material, information, he/she will be liable to removal from Contract and also such other action as the IIT Patna administration may deem necessary.

If I, Dr. _____ is offered the contract appointment on above terms and conditions. I will immediately convey the acceptance within 03 days from date of receipt of letter of appointment and report for duty within 15 days from date of acceptance to the Registrar IIT Patna, failing which it will be presumed that I am not interested in the appointment offered and the same will be treated as cancelled.
