### Terms of Reference (ToR)

As per the provisions in the Re-vamped NFSM Operational Guidelines 2019-20, and in pursuance to Ministry's letter No. 21-1/2018-NFSM (CA-V) dated 10<sup>th</sup> October, 2018 and letter No. 21-2/2019-NFSM(CA-V) dated 17<sup>th</sup> February, 2022, applications are invited from the interested candidates for the engagement of one (01) consultant purely on contractual basis in the Directorate of Rice Development, Patna (Bihar) with a consolidated monthly remuneration of Rs. 65,000/- Plus Rs. 3,000/-transport allowance for working under National Food Security Mission (NFSM) for financial year 2022-23 initially up to 30.09.2022 with the following eligibility criteria and terms & conditions:-

#### **1. Educational Qualification/Experience:**

- (i) Doctorate Degree in Agronomy/Agriculture Extension/Soil Science/Plant Breeding/Plant Protection/ Agriculture Engineering or any other agriculture subject having at least 10 years of field experience (experience may be relaxed to otherwise well qualified suitable candidates by the Selection/Screening Committee).
- (ii) Ability of analyze data and preparation of projects, writing report/seminar notes/articles, as evidenced by publication in national and international journals.
- (iii) The person should have the ability of team leadership & motivation.

#### **2. Age Limit:**

The age limit of consultant will be below 65 years. Age will be computed as on the last date of the Application. Candidate beyond 65 Years of age will not be considered.

#### **3. Remuneration of Consultant:**

The Consultant will be engaged with a consolidated monthly remuneration of Rs. 65000/- + Rs. 3000/- travelling allowance. He/She will not entitled for any other allowances. However, he/she will be eligible for TA/DA for undertaking official tours/ visits, if any, in connection with the implementation of the NFSM scheme at as per GOI rules equates to Grade "B" Gazetted Officers. Retired Government candidate's honorarium payment will be subject to other terms and conditions of GOI as per Extant Rules.

#### **4. Period and nature of engagement:**

Engagement of consultant will be made purely on contractual basis initially for a period up to 30.09.2022 during financial year 2022-23, which may be extendable based on performance and continuation of the Scheme & approval of the Competent Authority of Ministry thereof. The engagement will not confer upon the Consultant any right for the regularization of his/her service in the Directorate or any other organization agency in future.

### 5. Place of Posting:

The finally selected candidate will be engaged to work only at Directorate of Rice Development, Patna, Karpuri Thakur Sadan, Patna (Bihar).

### 6. Duties of Consultant:

- Liaisoning with SAUs, ICAR institutes & Commodity Directorates.
- Identification and delineation of acid/alkali soils in the State.
- Updating of package of practices of mandated crops and making the same available to the State/Districts.
- Assessment of requirements of inputs for the States based on targets approved by GOI.
- Development of training and activity schedule for cropping System based Training.
- Planning of field demonstrations and supervision of the same.
- Training of field staff engaged in NFSM work.
- Identification of promising crop varieties/hybrids of the mandated crops for the state.
- Analysis of yield advantage attributable to improved practices/technology with due consideration to seasonal weather conditions incidence of pest and diseases, soil conditions etc and reporting the same.
- Development of seed rolling plan for NFSM districts in consultation with SAUs state seed corporation & state department of agriculture
- Implementation of DBT at state & district levels
- Making available technical information required by national level monitoring team during its visit to the state.
- Development of technical literature/extension materials for farmers.
- Compilation and documentation of contribution of various interventions under cluster demonstrations lessons learnt and success stories from NFSM districts.
- To provide technical support to the Directorate/ officer of the Directorate on matters related to interventions of the mission.
- To render overall help to the technical staff working in the Directorate.
- To perform other tasks specified by Director, Directorate of Rice Development.


### 7. General Conditions:

- i. The candidates fulfilling the educational qualification/experience, age and other eligibility criteria will be shortlisted by the Screening/Selection Committee.
- ii. The shortlisted candidate will be called for appearing in selection process & personal talk/ interview by the Selection Committee, whose decision will be final and abiding.
- iii. The shortlisted candidates will be informed about exact date and time of selection process & personal interview/ talk by electronic mode on e-mail / or mobile, for which the candidate should compulsorily mention their E-mail/ Contact/ Mobile No. in application form.
- iv. The shortlisted candidates called for selection process shall be required to bring/ produce original certificates of educational qualification, experience certificates at the time of personal talk/ interview.



- v. No TA/DA will be admissible for attending selection process/ interview.
- vi. The Director, Directorate of Rice Development, Patna reserves the right to accept or reject any application without assigning any reason and also can withdraw the vacancy at any stage.
- vii. The selected Candidate will be given an offer of appointment asking him/her to report the duty in allotted time after furnishing a non-disclosure undertaking. If the selected candidate fails to join duty in given time, his offer will be cancelled and offer will be given to next candidate of the reserve list.
- viii. The selected candidate on Consultant post shall be eligible for 8 days' Casual Leave in a calendar year on pro-rata basis. No other type of Leave will be admissible. No remuneration for the period of absence in excess of the admissible leave will be paid.
- ix. TDS will be deducted from the monthly remuneration of the Consultant as per extant Govt. rules. A TDS certificate shall be issued by the DDO on demand.
- x. The engagement of a fresh candidate on Consultant post shall not confer any right for regular or continuous employment in the Directorate and engagement of a retired employee will not be considered as a case of re-employment.
- xi. If found guilty of any misconduct, the competent authority of Directorate may terminate the engagement of the Consultant at any time without assigning any notice, even before the expiry of the contract period.
- xii. In case of unsatisfactory performance, the Consultant will be given a notice of 30 days and his/her contract services will be terminated and offer may be given to next candidate on the reserve list.
