**Subject: - Recruitment for the posts of Junior Resident (Non-Academic) on Ad-hoc basis for 89 days at All India Institute of Medical Sciences (AIIMS), Patna.**

AIIMS, Patna invites application for filling up the posts of Junior Residents (Non-Academic) in various departments on Ad-hoc basis for 89 days in prescribed format and on the terms and conditions as mentioned in annexure "A".

\*Note: - Executive Director, AIIMS, Patna reserves right to vary vacancies (Increase/Decrease/Cancel) including reserved vacancies as per Govt. of India rules/circulars and requirements.

**As per EWS guidelines, if vacancy earmarked for EWS cannot be filled up due to non-availability of a suitable candidate belonging to EWS, such vacancies for that particular recruitment year shall not be carried forward to the next recruitment year as backlog and these vacancies may be filled up as unreserved vacancies.**

### ESSENTIAL QUALIFICATION (as on last date of application):

- The candidates should have passed MBBS (including completion of Internship) from the MCI/NMC recognized Institute.
- NMC/MCI/State Registration is mandatory to be produced before joining, if selected.

### UPPER AGE LIMIT (As on last date of receipt of application form): 37 years.

- Relaxable for SC/ST candidate up to a maximum period of 05 years, and in the case of OBC candidates, up to a maximum period of 03 years.
- In the case of Orthopedic / Physical Handicapped (OPH) candidates, relaxable upto maximum period of 05 years for General Category, 08 years for OBC category and 10 years for SC/ST category candidates.
- Reservation for SC/ST/OBC/EWS/PwBD shall be applicable as per Govt. of India rules.
  - **OBC Candidate's** eligibility will be based on the caste(s) borne in the Central list of Government of India. OBC Certificate should not be older than one year as on last date of submission of online application form. OBC candidate(s) should not belongs to Creamy Layer and their sub-caste should be matched with the entries in Central List of OBC, failing which their candidature will not be considered under any of the applied reserved category post(s).

- For SC/ST Candidates - Certificate should be issued by rank of Tehsildar or above in standard format of Central Government.
- PwBD Candidates – The disability certificate should be signed by duly constituted and authorized Medical Board of the State or Central Govt. Hospitals/Institutions & countersigned by Medical Superintendent or equivalent. The constitution of the Medical Board will be of one consultant each from disciplines of Orthopedics, Physical Medicine & Rehabilitation and Surgery.

• **RESERVATION FOR ECONOMICALLY WEAKER SECTIONS (EWS):**

The vacancies advertised under EWS Category are as per the instructions issued by DoPT, Ministry of Personnel, Public Grievances & Pension, Govt. of India, vide OM. No. 36039/1/2019-Estt (Res), dated 31.01.2019. Application under EWS category will be considered subject to submission of Income and Assets certificate on a prescribed format issued by the competent authority and subject to verification of genuinity of the certificate by the issuing authority. As per DoP&T OM No. 36039/1/2019-Estt (Res), dated 31.01.2019, the crucial date for submitting income and asset certificate by the candidate is the last date of receipt of application form, except in cases where date is fixed otherwise. Therefore, a valid EWS certificate will be the one which has been issued by the competent authority, as prescribed by the GOI/DOPT. Candidates who fail to produce valid EWS certificate will not be considered for reservation under this category. They will however, be considered for UR category. Therefore, EWS candidate must ensure that they have a valid EWS certificate on the last date of receipt of application form. **The EWS certificate must be valid for financial year 2022-2023 and issued on or after 01.04.2022 & on or before last date of receipt on application form i.e. 12.10.2022 based on income of year 2021-2022.**



**TERMS & CONDITION (ANNEXURE – “A”)**

- Tenure:** - The tenure for the posts of Junior Residents shall be as per Residency Scheme laid down by the Ministry of Health & Family Welfare, Government of India. The maximum duration will be extendable upto one year as per Residency Scheme (Adhoc/Regular), including the duration of residency already rendered by the applicant in any hospital of govt. / public sector undertaking / autonomous bodies funded by the govt. prior to this appointment, if any.
- Expiry of Appointment:** - The appointment is for 89 days and can be terminated at any time by the Institute by giving one week notice or salary in lieu thereof. The employee can also leave the Institute by giving one week notice or salary in lieu thereof. The appointment shall be terminated immediately on the basis of unsatisfactory work or continued absence or on disciplinary grounds. If termination of service is made on the basis of unsatisfactory work or due to continued absence of the appointee or on the disciplinary grounds, then he/she will not be entitled for any salary in lieu of notice period.
- Salary:** - The appointee will be entitled to salary as per residency scheme of Govt of India, as amended by the Government from time to time.
- Leave:** - 2 ½ days per month.
- The Competent Authority reserves the right to change the number of vacancies, withdraw the process in full or in part and also the right to reject any or all applications received without assigning any reasons or giving notice etc.
- The prescribed qualification is minimum requirement and mere possessing the same does not entitle any candidate for selection.
- This appointment is whole time and private practice of any kind is prohibited. He / She will have to work in shifts and can be posted at any place in the Institute.
- Candidates have to join within 15 days from the date of declaration of result. **No extension will be allowed under any circumstances.**
- He / She should also note that he/she will have to conform to the rules of discipline and conduct as applicable to the Institute employees.
- No travelling or other allowances will be paid to the candidate for interview / joining the post.
- The candidate should not have been convicted by any Court of Law.
- Canvassing in any form will render the candidate disqualified for the post.
- All information pertaining to this advertisement including date of interview, notices, result etc. will be displayed on the AIIMS Patna website (www.aiimspatna.edu.in). No individual intimation will be sent by AIIMS Patna to applicants.
